The conditions on using Complimentary Admission Tickets are as follows:

1. The admission tickets are One-day Tickets.
2. The admission tickets are non-transferable, non-exchangeable, non-refundable and will be void if altered.
3. Admission tickets are subject to validity dates set out on the back of the tickets and will be **invalid after the expiry of the validity**. Admission tickets are further subject to the validity dates specified for different ticket tiers in the next three months, which are set out in the Ticket Tier Calendar available on the Hong Kong Disneyland website at [www.hongkongdisneyland.com](http://www.hongkongdisneyland.com). The Ticket Tier Calendar and dates are subject to the Park’s operations and may be changed at any time and from time to time. Guests are advised to check the latest Ticket Tier Calendar before their park visit. Validity dates are subject to the Park’s operations and may be changed at any time and from time to time.
4. Guests are required to make reservation with valid tickets or membership cards before visiting the Park. Park visit reservation of each type of ticket or membership card is subject to a limited quota. Reservation will not be accepted once the respective quota is full.
5. The admission tickets and admission to the Park are subject to the Rules and Regulations of the Park and such other applicable terms and conditions, which are set out in the Hong Kong Disneyland website at [www.hongkongdisneyland.com](http://www.hongkongdisneyland.com), the Park’s mobile app and Guest Relations, as the same may be modified at any time and from time to time. Guests are advised to check the Hong Kong Disneyland website prior to their park visit.
6. The tickets will be given to awardees in early July.
