SSPA Briefing Session on CA and Notes on CA

I. Briefing Session on CA (2021/2023)

To familiarize parents of P.6 students with the Central Allocation System, the school will organize a briefing session. All Primary 6 class teachers will meet parents for any inquiries concerning the choice of secondary schools.

II. Notes on CA

1. The "Handbook for Unrestricted School Choices", "Secondary School List", "Notes for Parents on Central Allocation" and "PPT for NCS & SSPA (English version & translated version - Bahasa Indonesian, Hindi, Nepali, Punjabi (Indian), Tagalog, Thai, Vietnamese and Urdu)", are also available on Education Bureau homepage (<https://www.edb.gov.hk/en/edu-system/primary-secondary/spa-systems/secondary-spa/general-info/>).
2. Parents / Guardians are advised to read the basic information about secondary schools (including the information on the planned subjects for S1 in 2022/23, the elective subjects offered and the number of S1 classes operated) from the "Secondary School Profiles 2022/2023" distributed in December 2022 by the Committee on Home-School Co-operation. Parents are also advised to visit the website of the "Secondary School Profiles 2022/2023" (<https://www.chsc.hk/secondary/en>) for more updated information of secondary schools.

III. Notes for Completing the Choice of Schools Form

1. Before making school choices, parents should watch the video on the SSPA System 2021/2023 issued in October 2022. Parents may also visit the EDB website (<https://www.edb.gov.hk/en/edu-system/primary-secondary/spa-systems/secondary-spa/general-info/>) for other languages catered for non-Chinese speaking students (NCS)

2. To ensure sufficient places, each school net comprises:
 - **all** participating secondary schools located in their own district; and
 - **a number of** participating secondary schools in other districts
 - the number of secondary schools and school places provided from other districts may vary from year to year according to the demand and supply situation.
3. Parents may submit the CA form using either paper form or use the SSPA e-platform via “iAM Smart+” app starting 2023, please ask the class teacher for details if necessary.

For paper forms:

- 1 Part A - Unrestricted School Choice (Refer to the Handbook for Unrestricted School Choices, choose a maximum of 3 schools)
- 2 Part B - Restricted School Choices (Refer to the Secondary School List of the student’s own net, choose a maximum of 30 schools)
- 3 DO NOT repeat the choices in the same part and do not choose only a few favourite schools in Part B. This **will not increase** the chance of the student being allocated to the school.
- 4 Parents should complete the paper form with a **black ball pen**.
- 5 Please write the student’s Chinese name (as in the identity document) above the English name.
- 6 Please note that in the morning of the day for the announcement of allocation results this cycle, the Education Bureau (EDB) will also inform parents of their child’s allocation result via SMS messages at around 10 a.m. Parents wishing to receive the related SMS notification should provide a mobile phone number which can receive SMS messages in the specified box on the Secondary One Choice of Schools Form (Choice Form) (SO307). The SMS notification supports both 8-digit local and 11-digit mainland phone numbers (e.g 123 4567 8901). Please **don’t** add telephone area codes (i.e “+852” or “+86”) or add any separators when filling in the phone number on the form. (Please refer to the diagram.)
- 7 If parents have been notified by the secondary schools about the successful offer in the Discretionary Places stage, or is admitted by Jockey Club Ti-I College, you **do not need** to fill in school choices, but you **need to sign** on the form after filling in contact information and cross out the parts on school choices.
- 8 On the other hand, if a student is admitted by a DSS secondary school not participating in the SSPA System (non-participating DSS secondary school) and the parent has signed an undertaking with and surrendered his/her P6 Student Record Form to the school, or admitted by other schools (e.g. international schools or private schools) and decided not to participate in Central Allocation (CA), the parent **need to sign** on the form after filling in contact information and cross out the parts on school choices . (Please refer to the diagram).


V. Dates for Registration of Secondary One Students
