## **Invitation for Study Tour to Mainland China**

To understand the development of the cities in the Greater Bay Area, thereby developing students' sense of national identity, our school may organize Study Tours to Mainland China for senior level students.

The students will be accompanied by teachers throughout the trip. A set of learning tasks is designed to gear to this experiential learning trip. The tasks are devised to induce self-directed, as well as reflective learning. Participants are required to complete the learning tasks and present what they have learnt during the sharing session.

Our school is providing gratuitous assistance to the participants as facilitators without liability. Whilst the accompanying staff and helpers in charge of the group will take all reasonable care for the health and safety of the participants, they cannot be held responsible, for any injury, illness, damage or loss suffered by the participants during or arising out of the journey.

The tour fee is approximately HK\$300 to HK\$500, depending on whether it is a 1-day tour or 2-day tour. The students are to pay only 30% of the tour fee. 70% of the tour fee is subsidized by Education Bureau. There will be a pre-tour briefing for students and parents. Details of the study tour will be announced when the trip is confirmed. Passport holders need to apply for visas accordingly.
